Bid Sheets for each Unit will be available in the Mora office for those who wish to place a sealed bid on a unit(s).

Bid Sheets are to be delivered in a sealed envelope marked "Surplus Unit Bid". The sealed envelope shall include a completed bid sheet signed by the person/entity bidding on a unit(s).

Sealed Bids are to be submitted by mail or in person to the Mora Office, P.O. Box 240, Mora New Mexico, 87732, or 501, Highway 518, Mora New Mexico.

DEADLIND TO SUBMIT BIDS IS OCTOBER 17, 2024 BY 5:30 PM.





Sealed Bids received not marked as required, lacking signatures, or received after the deadline will not be accepted as complete bids.

Units will be sold to the highest bidder for the unit identified. Arrangements for processing titles will occur after successful bidders are announced and payment takes place. High Bidders will be notified so payment can be made and the removal of the unit can be arranged.

Failure to remove the unit from the MSMEC yard within 10 days after the award is announced will result in the bid being forfeited.

Upon forfeiting of a bid, a MSMEC may award to next highest bidder.

Bid Sheets shall be obtained from inside the Mora office.
